### CLOSURE OF NON-RENOUNCEABLE ENTITLEMENT OFFER

The Directors of Potash West NL are pleased to announce that the fully underwritten, non-renounceable pro rata Entitlement Offer of shares made pursuant to a prospectus lodged on 15 January 2014 has closed.
